I. New Business:

- 2) Public Hearing Ms. Dias made a motion to open the public hearing for a Body Art Establishment permit, 2nd by Mr. Perkins.
 - (a) Body Art Establishment Brianna Frye came before the Board for permitting of her Lash Studio to do Body Art in the form of permanent makeup. She has already been approved by the Zoning Board of Appeals. Another inspection by the Health Agent is required. Ms. Dias made a motion to approve the Body Art Establishment, 2nd by Mr. Perkins. 2-0
 - (b) Body Art Practitioner Brianne Frye came before the Board for permitting as a Body Art Practitioner. Ms. Dias made a motion to approve Ms. Frye as a Body Art Practitioner, 2nd by Mr. Perkins 2-0

- 3) Sausage Homemade 421 Franklin Street. Ms. Glinna Tassinari is looking for relief from having to pump her grease trap on a quarterly basis 310CMR 15.351.2. Ms. Dias made a motion to have the business owner self monitor and pump annually, 2nd by Mr. Perkins. 2-0
- 4) Kim Bombardier Ms. Dias made a motion to appoint Ms. Bombardier as temporary Public Health Nurse, 2nd Mr. Perkins. 2-0
- 5) Retention/Detention Areas Don Howard came before the Board to discuss the retention and detention areas within the Town that need attention. He is concerned with mosquito control with standing water. He has also discussed this issue with the Select Board. Mr. Howard would like all retention/detention areas to be underground.
- 6) Septic Plans for Approval
 - a. **500 Liberty Street** –511 gpd- Ms. Dias made a motion to approve the plan as submitted, 2nd by Mr. Perkins. 2-0. Pending receipt of revised plan listing sieve waiver.
 - i. Allow a reduction in separation from bottom of the SAS to seasonal high ground water from 4' to 3.1'.
 - ii. To allow the use of a sieve analysis in lieu of a perc test.
 - b. **991 Monponsett Street** 2 Bedroom –Ms. Dias made a motion to approve the plan as submitted, 2nd by Mr. Perkins. 2-0
 - i. To allow a reduction in the required setback from the SAS to the property line from 10' to 5'.
 - ii. To allow a reduction in the required setback from the SAS to the slab foundation from 10' to 5'
 - c. **842 East Washington Street** 3 bedroom Ms. Dias made a motion to approve the plan as submitted, 2nd by Mr. Perkins. 2-0
 - i. To allow the use of a sieve analysis in lieu of a perc test.
