 - (a) Stickers – Ms. Dias would like to have Bonsai Logic come before the Board at the February meeting. The company deals with Transfer Station Stickers. Ms. Dias will contact them and have them come to the next meeting.
- 5) **1006 West Washington Street** – Tabled. Wetland must be delineated. The Board will wait to approve the plan until delineation is complete. Mr. Perkins made a motion to table the septic plan for 1006 W. Washington Street, 2nd by Mr. Butler 3-0
- 6) Agent Report – The dog pound will be reactivated at the Transfer Station. A tree company has been hired to take down some trees near the kiosk and the trees in between some of the containers. The land use boards have been getting together every Monday to discuss various projects going on in Town.
