- The contract/permit process is very cumbersome and a hired hand is needed to guide and make certain we do things correctly. We have a grant equivalent of \$250k from state (USDA) – Fed reserve funds...we could lose if we do not do this correctly or timely.
- Will bring 100 acres more valuable to town....enhancing recreation for ponds/streams
- o 2 projects similar (Eel River and TID Marsh)
- Conservation has funds in hand for contract services
- Town Accountant has reviewed and approved for spending.
- Ms. FitzGerald-Kemmett has walked this property. She agreed to points and felt comfortable if Conservation and Town Accountant too approved.

 - Hearing held at 7:30pm time.
- Mr. McGahan read to audience of Tax Classification hearing notice

In accordance with Massachusetts General Laws, Chapter 40, Section 56, a public hearing will be held in the Selectmen's Meeting Room, Town Hall, Hanson, Massachusetts on Tuesday, November 14, 2017 at 7:30 P.M. for the purpose of allocating the percentage of tax levy to be borne by each class of property for Fiscal 2018. All interested taxpayers are encouraged to present oral or written information on their views. This is a necessary hearing, which must be held prior to certification of the fiscal 2018 tax rate.

- Handout from Assessors Town of Hanson Fiscal Year 2018 Classification Hearing. (November 14, 2017)
 - Mrs. Gamache discussed the document in detail...on %'s and Class (residential, open space, commercial, industrial and personal property.
 - She indicated 3 votes required action by the BOS.
 - Reviewed 2018 proposed figures uniform tax rate was recommended although shift %'s were reviewed and discussed.
 - o Comparisons from fiscal year 2016, 2017 and 2018 was made.
 - Tax Levy was discussed and reviewed. Excess levy is \$14,508.93...this is the difference of what we could use and what we are using...
 - Call to Vote:
 - 1. Motion by Mr. Howard, 2nd by Mr. Hickey –to maintain the residential factor for fiscal year 2018 to a factor of 1 meaning the tax rate should NOT be split in order to shift more tax burden to Commercial Class vote = 4-0-0 (in favor to maintain)
 - 2. Motion by Ms. FitzGerald-Kemmett, 2nd by Mr. Howard to NOT adopt a Residential Exemption vote 4-0-0 (NOT to adopt)
 - 3. **Motion** by Mr. Hickey; 2nd by Mr. Howard to NOT adopt a Small Business Exemption **vote 4-0-0 (NOT to adopt)**
 - Motion to close hearing by Mr. Howard and 2nd by Mr. Hickey. Vote was 4-0-0 to close.
