Discussions

Consider possible appointment of newest Trails Committee member, Will Foshey as an Associate Member of the Commission, in order to enhance his understanding of important principles that guide trail creation & management (our Blanket Notice of Intent, WPA, etc.) – Mr. Clemons requested that this be tabled again as he hasn't had a chance to touch base with Will yet.

1101 Main Street/Enforcement Order

Mr. Kemmett commented that the Commission had requested an enforcement order (EO) in 2011 but only two members from that Commission now remain. He asked Ms. Muncy to update the new members on that enforcement action. Ms. Muncy said that the issues at the site had been a lack of erosion control, an unpermitted shed and vehicles in the resource area. Somehow, the EO had fallen by the wayside but that the three new commission members may want to conduct an inspection to familiarize themselves with the site. Mr. Clemons commented that he may have to recuse himself as he had conducted a wetlands delineation for this site some time ago. Also, he is pretty close to being an abutter.

Mr. Kemmett added that there are two very large files in the office. Mr. Schellenger asked if there was a summary in the file. If not, a summary would be useful before going out to inspect. Mr. Muncy said she would create one if it doesn't exist and would email it to the Commission members. Mr. Kemmett asked that the subject be put on the February 9th agenda and at that point, the Commission can decide how to move forward.

Smitty's Bog Power Point presentation prepared by Laurie Muncy

Ms. Muncy had prepared a Power Point to give an overview of the progress at Smitty's Bog as it pertains to the USDA's Wetlands Reserve Program (WRP). Using a projector to make the presentation, a map of the project was displayed on the wall of the meeting room that depicted the areas of work and the restoration objectives: removal of the water control structures and dikes and removal of invasive phragmites. Other plan objectives are to plant American White Cedars and install deer fencing. Invitations to Bid are being sent out this week for that part of the restoration.

A breach of dike #22 was performed last month to alleviate flooding at Katydid Lane and the water is now flowing. Compatible uses for the property include vista pruning, the installation of Kestrel nesting boxes and signage (kiosk). Ms. Muncy and the Town Administrator are meeting with a representative from Natural Resources Conservation Services (NRCS) next week to discuss the project, specifically the Request for Proposals for the removal of the water control structures.
