Update on Wetlands Restoration Plan for Smitty's Bog

Mr. Clemons reported that the Commission had received a little positive publicity recently about the continued restoration project at Smitty's Bogs. Smitty's Bogs is an area that was for many years, privately owned and primarily used for cranberry cultivation. It is now being restored to wetlands and their natural ecological function under the NRCS's Wetlands Reserve Program. Solitude Lake Management Co. were contracted to come to Smitty's Bog last Thursday with a "Marsh Master" to mow down the phragmites that they initially treated last September with an herbicide. Because the phragmites are an invasive species, they crowd out the native plants impeding stream flow and native animals from their natural habitat. Tracy Seelye from Hanson Express Newspapers was on hand to capture the story and wrote a great article for last week's edition. Mr. Clemons said that it was a positive step towards helping people to understand what's going on at there.
