7:15 PM Continued Notice of Intent for authorization of a utility maintenance project to replace the existing Structure 85 along electric transmission Line 191 within 100' of bordering vegetated wetlands located at Utility Right-of-Way (ROW) Whitman Street, Map 101, Lot 2, for Matthew Devlin, NSTAR Electric Company, represented by Tighe & Bond, Inc., 4 Barlows Landing Way, Unit 15, Pocasset, MA 02559. (**DEP# SE175-0745**) (**New Hearing**)

Green cards were verified. Amanda Houle, Tighe&Bond presented proposed plans to the Commission. Eversource is proposing scheduled maintenance to replace overhead utility poles. There are a total of 96 structures; some fall within Hanson. Eversource will provide the office 48 hours notice in advance when work begins. Ms. Houle stated the contactor has not been awarded yet. They would then have to coordinate outages well in advance. They are planning on replacing September – November, by end of calendar year, late August if possible. They provide turtle and species training for awareness.

Two of the poles do not fall within exemption. Structure 71 located at Winter Street&East Washington Street is currently within bordering vegetated wetlands. The footings required to fit pole are bigger, getting replaced with steel

(currently wood). It will require concrete foundation and will have 3 settings. Based on enlargement, they are requesting BVW replication and will put in a few native shrubs and NE seed mix; and it will be monitored for two growing seasons. {There will be mats used}.

Ms. Houle stated that Structure 85 is between the edge of Whitman Street and there is a pole on edgeway, and they would have to go into wetland. They tried to keep as close as to the wetland boundary and would like to get authorization from Commission. Based on the larger footings, there are 3 poles and they will be directly embedded, these are different type of footings are required, no concrete, and there will be crushed stone and steel pols.

Steven Marshall, South Shore Habitat and Humanity – Property adjacent was purchase with the intent to build affordable housing, concerned about the poles changing from wood to steel.

Amanda Houle – Structure material is required; the utility company needs to replace with a material less susceptible to storm damage. She will make sure to connect Mr. Marshall with someone to communicate about project.
