Ms. Parker notified Commission that they have had an Osprey Dragon Boat Team in Boston for 16 years. It is a competitive paddling sport. The boat is about 650 lbs. and can hold up to 22 people. There is no motor on the boat. It is has become difficult to run in Boston and they would like to start a team in Hanson to build a community co-ed adult sport. They are 501(C)(3) non-profit.

The request is to dock boat at the location of lily pads from April-September and leave on the water until the Season ends so they would not impede any other traffic. Mr. Parker stated they would primarily be holding weekday practices on Wampatuck Pond and also start recruiting paddlers. They plan on using a lobster-pot type buoy with a line on that will pair with cinder blocks, mooring can be pulled out during off-season.

Chair Clemons discussed other ponds in the area and the concerns regarding cynobateria in water. The Commission discussed vandalism concerns and also parking for practices.

Agent Schellenger stated that in order to have this, you would need approval from the Harbormaster, Mr. O'Brien, at Hanson Fire Department.
