Request for a Minor Modification to the Amended Order of Conditions for Area 5 Groundwater Well Development off Old Pine Drive to allow the DEP - required pumping test for the two (2) test wells TW1 and TW2, including installation and instrumentation in the Bordering Vegetated Wetland (BVW) (DEP SE#175-0694).

Magdalena Lofstedt, CDM Smith, was present to go over the modifications for 2 conditions:

Ms. Lofstedt stated that the work would include $\underline{5}$ 2" PVC observation wells in the buffer zones of the BVW (instead of 4 as stated in the Amended Order of Conditions 54B), as shown on Site Place C-2. **The observation wells would stay, but the piezometers and staff gauges would be removed** manually to prevent/minimize disturbance to the BVW. The Conservation Department shall be notified (at least 24 hours) before the work in the BVW to permit witnessing these installations and removals.

The Town of Hanson Water Department is requesting that the following condition be added:

- 1. Spreading the drilling spoils will be hand raked around the area of the observation well (but not in the wetland).
- Disposal of water generated by drilling, development, or pump test procedures shall be in a responsible manner that does not cause erosion, siltation, or other property damage to the extent possible. Methods and materials are subject to the approval of the Hanson Conservation Commission.
- Well development shall be discharged to a dirtbag to capture sediment materials and outlet to the adjacent wetland resource area. Variations on this procedure must be approved by the Hanson Conservation Commission.

Ms. Lofstedt requested that the spreading of the drilling spoils be hand raked around the area of the observation well, but not in the wetland.

Ms. Lofstedt also discussed the dirtbag, which is basically a filtration bag. It is semi-permeable and the dirt is cut out after use. It is about the size of 2 conference room tables.

Discussion regarding the wording in the original Order of Conditions which should be revised. The Water Department requested that Conditions #46, 47, and 48 in the original Order of Conditions be revised to read:

- 46. No heavy machinery to trucks shall be stored within wetland resource areas or the 100-foot buffer zone resource areas. This provision does not apply and the subcontractor's plan as presented at a November 13, 2018 meeting with the Hanson Conservation Commission and engineer is approved.
- 47. No refueling of equipment or trucks shall occur within 100 feet (horizontal distance) of wetland resource areas. This provision does not apply, and the subcontractor's plan as presented at the November 13, 2018 meeting with the Hanson Conservation Commission and engineer is approved.
- 48. There shall be no more than a total of 50 gallons of fuel (other than what is in vehicles) or maintenance chemicals relating to this construction stored on the site in an area subject to the Conservation Commission's jurisdiction at any one time. No routine servicing of vehicles used for this project shall be permitted on the site. The Conservation Commission and the Board of Health shall be notified prior to initiating any emergency repair on the site. This provision does not apply, and the subcontractor's plan as presented at a November 13, 2018 meeting with the Hanson Conservation Commission and Engineer is approved.

Discussion on Conditions 46, 47, and 48. Ms. Lofstedt stated that under 48, she would like Conservation Commission to be aware they need to refuel the pumps and the pumps are within 100' buffer zone. The point is they want to be able to drive their pick-up truck into the 100 foot zone. The same applies for 47.

Discussion on the type of plastic that would be in place to catch any potential leaks.

Agent Schellenger said the light vehicles may remain provided secondary containment acceptable to the Conservation Commission.

Wording changes were proposed as follows:

Condition 46 to be revised to read: No heavy machinery or trucks shall be stored within wetland resource areas or the 100 foot buffer zone resource areas. Light trucks and equipment for the pumping test may remain within the 100 foot buffer zone during the pumping test provided secondary containment acceptable to the Hanson Conservation Commission is placed under them to collect any oil or gas leakage.

Condition 47 is revised to read: No refueling of equipment or trucks shall occur within 100 feet (horizontal distance) of wetland resource areas except as needed to refuel the pumps, added by hand (i.e. gas container). Secondary containment acceptable to the Hanson Conservation Commission shall be in place to catch any potential leaks.

Condition 48: No changes.

Condition 54B is revised to read: This work includes installation of five (5) 2 inch PVC observation wells in the buffer zones of the BVW, and five (5) piezometers in the BVW, and three (3) staff gages, 2 of which in the BVW, all as shown on Site Plan C-2. Piezometers and staff gages installed in the BVW should be installed manually - no construction equipment/vehicles shall be permitted in the BVW. The observation wells will remain, but the piezometers and staff gages shall be removed manually to prevent/minimize disturbance to the BVW. The Conservation Department shall be notified (at least 24 hours) before the work in the BVW to permit witnessing these installations and removals.

Condition 54C is added to read:

- a. Spreading the drilling spoils will be hand raked around the area of the observation well (but not in the wetland).
- b. Disposal of water generated by drilling, development, or pump test procedures shall be in a responsible manner that does not cause erosion, siltation, or other property damage to the extent possible. Methods and materials are subject to the approval of the Hanson Conservation Commission.
- c. Well development discharge shall be discharged to a dirtbag to capture sediment materials and outlet to the adjacent wetland resource area. Variations on this procedure must be approved by the Hanson Conservation Commission.

Motion to approve Minor Modification to the Amended Order of Conditions for Area 5 Groundwater Well Development off Old Pine Drive with the revised wording: Sharon LePorte

Update on Sleeper property acquisition - Mr. Clemons.

Mr. Clemons discussed the Sleeper property acquisition. It is still going forward.

There was a meeting with Wildlands Trust and discussion with Town Planner in order for the Town of Hanson to receive funds. The Open Space Plan would also need full approval and we are pressing forward on that with the assistance of the Town Planner.

Mr. Clemons also stated that an outside firm would need to be contacted to perform an environmental assessment to assure all parties that there are no recognized environmental conditions with the site along with a baseline documentation report. Wildlands Trust would also need to visit the site and document conditions. The Town Counsel will have to look at the chain of title of the property to certify that it is clear, and we have budgeted to do a survey of the property, so the land has not yet been bought.
