- Discussion and vote on Event Playbook, Wedding Planning Guide, Camping and Rules – Secretary Flanagan provided a very thorough synopsis of all of the above. These will be sent out to the Commission and updated and sent out to the wedding couple 60 days in advance, 45 days, 30 days, etc. This will be very helpful to the entire process.


