## Recreation Commission Meeting September 7, 2021 6:30 p.m. Needles Lodge

### Approval of minutes:

• Approval of August 23, 2021 minutes

#### New Business:

- Discussion on Cranberry cove status with regard to sand wasps and prevention of sand wasps for next season – Input from Conservation Commission and Highway Department
- Mr. Phil Clemens, Conservation Agent stated that a very heavy storm has caused beach erosion and water flooding by the bath house. He provided a very thorough explanation. Mr. Clemens summarized storm water management, collaboration with Town's highway department, and to reduce the amount of sand on the beach. This falls within the jurisdiction of the Conservation Commission but it is also a Town issue. Chairman states the goal is to open the beach and provide swimming lessons next year. The concern still remains with the sand wasp's eggs in the sand. The next steps are informal discussion with Conservation, Highway next meeting agenda. Frank Milisi and Brian Smith to attend the Conservation Meeting.

Discussion took place concerning closing the beach for the season – It was determined to close it on September 19, 2021, at 6:00 p.m.

Discussion on next project by the Boy/Cub Scouts -- Patrick Powers, Hanson Cub scout
pack addressed the Commission. Scouts have done camping in the past, and have
potential dates to hike the camp. The date of September 21, 2021, is requested to meet
in the pavilion, will clean up after they leave. Will confirm that date is available, and
possible other dates.

• Discussion on Policies and procedures – This continues to be revised, and will check the status of Town Counsel's recommendation. Madi Storey requests that specific rules as far as the bar service be put in the policies and procedures, so that there is a policy in place if the liquor license is being violated.

# Old Business/Correspondence:

• Chairman walked the grounds with Ed Sheehan, Sheehan Landscape, and the circle is 500 feet around. He will itemize the cost of the trees and the labor, and provide a cost for mulch.
