Recreation Commission updated on upcoming Halloween Extravaganza and Cornhole Tournament.

Bill Boyle notified Recreation Commission that he emailed the draft of both the Business Plan and Policies and Procedures. He requested that the Recreation Commission continue to feed information, additions, edits, updates and once it is inputted they will have the draft to vote on. He mentioned to follow the same procedure regarding emailing to Recreation Director and cc: Recreation Chair.

Joan Fruzzetti has Business Plan Draft and said the figures are wrong and there was no way we can present this to the town. Bill Boyle notified Recreation Commission that these are both drafts so that things can be updated.

Matt Dyer said the Board of Selectmen Agenda does not say draft, Bruce Young feels that it should say progress on Camp Kiwanee Business Plan because he goes to meetings expecting that it is regarding Business Plan, but that's not your fault it's the Selectmen's problem.

Joan Fruzzetti said the rates are wrong.

Joan Fruzzetti said Article 18 regarding HVAC you can't ask for money unless we use up retained earnings.

Matt Dyer discussed 50/50 grant regarding tree planting.

Brian Fruzzetti would like to discuss Article 3:

To see if the town hall will vote to transfer \$73,000 from free cash, raise and appropriate from taxation, or retained earnings to supplement funding of the FY2020 Recreation operating budget or take any other action in relation there to MGL Chapter 44, Section $53F \frac{1}{2}$

Explanation:

These funds are needed to cover the current Fiscal Year expenses at Camp Kiwanee

Brian Fruzzetti also noted:

The city or town shall include its tax levy for the fiscal year the amount appropriated for the total expenses of the enterprise and an estimate of the income to be derived by the operations of the enterprise. If the estimated income is less than the total appropriation, the difference shall be added to the tax levy and raised by taxation. If the estimated income is more than that total appropriation, the excess shall be appropriated to a separate reserve fund and used for capital expenditures of the enterprise, subject to appropriation, or to reduce user charges if authorized by the appropriate entity responsible for operations of the enterprise. If during a fiscal year the enterprise incurs a loss, such loss shall be included in the succeeding fiscal year's budget.

Brian Fruzzetti said he does not want to list specific expenditures, he would like it to be a broader base and if there are questions, we can answer with specifics.

Bill Boyle will talk to Town Accountant, Todd Hassett. We are appropriated a certain amount such as for WIFI. Discussion on salaries.

Brian Smith would like to have Bill Boyle, himself, and Bruce Young to meet after speaking with Todd Hassett and have Bruce Young as a financial consultant.

Bill Boyle said he would rather speak to Meredith Marini regarding this.

Bruce Young said that he has an excellent relationship with Todd Hassett.

Brian Fruzzetti asked again if there would be an issue with meeting with himself, Recreation Director, and Bruce Young?

Bill Boyle said he would like to speak with Todd Hassett as well and would rather not make a decision without speaking to the Town Administrator and Town Accountant.

Brian Fruzzetti said he was not questioning Todd Hassett, he's not saying Todd Hassett ripped us off, he wants to know what's going on.

Diane Cohen said to notify Meredith Marini of this request and then go from there.
