## **May 2007 Special Town Meeting**

Special Town Meeting  
May 7, 2007

Moderator Charles W. Mann called the meeting to order at 7:36 p.m. in the auditorium of the Middle School with Patricia Rich, Robert Hayes and Stephen Amico appointed and sworn in to serve as tellers.

Town Counsel was John Goldrosen from the firm of Kopelman & Paige.

A quorum was declared present with 143 voters in attendance.

**ARTICLE 1:** To see if the Town will vote to transfer a sum of money from Free Cash to pay unpaid bills from fiscal year 2005 and 2006 or take any other action in relation thereto.

Proposed by the Board of Selectmen

**Explanation:** There are a few unpaid bills from various departments, which were received after the end of fiscal year 2006. Requires a 9/10 vote.

Finance Committee recommends.

**VOTED Aye, unanimous to transfer a sum of \$1,266.58 from Free Cash to pay unpaid bills from fiscal year 2006.**

**ARTICLE 2:** To see if the Town will vote to raise through borrowing the sum of \$193,205.00 in anticipation of reimbursement from the State under Chapter 291C, of the Acts of 2004, for continuing State Aid construction of public highways approved by the Board of Selectmen and the Massachusetts Highway Department or take any other action in relation thereto.

Proposed by the Highway Surveyor

**Explanation:** State aid chapter 90 monies to be received from the Commonwealth of Massachusetts for road paving and reconstruction that have now become available from the Massachusetts Highway Department and must be expended. Requires 2/3 vote.

Finance Committee recommends.

**VOTED Aye unanimous to raise through borrowing the sum of \$193,205.00 in anticipation of reimbursement from the State under Chapter 291C, of the Acts of 2004, for continuing State Aid construction of public highways approved by the Board of Selectmen and the Massachusetts Highway Department.**

**ARTICLE 3:** To see if the Town will vote to raise through borrowing the sum of \$86,808.00 in anticipation of reimbursement from the State under Chapter 122, of the Acts of 2006, for continuing State Aid construction of public highways approved by the Board of Selectmen and the Massachusetts Highway Department or take any other action in relation thereto.

Proposed by the Highway Surveyor

**Explanation:** State aid chapter 90 monies to be received from the Commonwealth of Massachusetts for road paving and reconstruction that have now become available from the Massachusetts Highway Department and must be expended. Requires 2/3 vote

Finance Committee recommends.

**VOTED Aye unanimous to raise through borrowing the sum of \$86,808.00 in anticipation of reimbursement from the State under Chapter 122, of the Acts of 2006, for continuing State Aid construction of public highways approved by the Board of Selectmen and the Massachusetts Highway Department.**

**ARTICLE 4:** To see if the Town will vote to transfer from Free Cash and/or transfer from the amounts appropriated in the May 2006 Annual Town Meeting, Article 5, Line 110 Other Tuition and Transportation the sum of \$25,000.00 to be added to the amounts in the May 2006 Annual Town Meeting Article 5, Line 95, Town Gasoline or take any other action in relation thereto.

Proposed by the Highway Surveyor

**Explanation:** These funds are needed as a result of the increase in gasoline and diesel fuel prices. The estimated amount of \$25,000.00 will cover the costs fuel for Town owned vehicles.

Finance Committee recommends.

**VOTED Aye unanimous to transfer from the May 2006 Annual Town Meeting, Article 5, Line 110 Other Tuition and Transportation the sum of \$25,000.00 to be added to the May 2006 Annual Town Meeting Article 5, Line 95, Town Gasoline.**

**ARTICLE 5:** To see if the Town will vote to transfer from Free Cash and/or transfer from the amounts appropriated in the May 2006 Annual Town Meeting, Article 5, Line 8 Unemployment the sum of \$7,000.00 to be added to the amounts appropriated in the May 2006 Annual Town Meeting Article 5, Line 99 Street Sweeping or take any other action in relation thereto.

Proposed by the Highway Surveyor

**Explanation:** These funds are needed to pay a contractor to sweep the streets of the sand that was applied for snow and ice control. The Town of Hanson does not own a sweeper however one week per month we have access to the Tri-Town Sweeper (Towns of Hanson, Hanover, and Pembroke).

Finance Committee recommends.

**VOTED Aye unanimous transfer from the 2006 May 1 Annual Town Meeting, Article 5, Line 8 Unemployment the sum of \$7,000.00 to be added to the 2006 May 1 Annual Town Meeting Article 5, Line 99 Street Sweeping.**

**ARTICLE 6:** To see if the Town will vote to transfer a sum of money from the amounts appropriated in the May 2006 Annual Town Meeting, Article 5, Line 93, Highway Department Wages to purchase one (1) new ½ Ton pick-up truck for the Highway Department or take any other action in relation thereto.

Proposed by the Highway Surveyor

**Explanation:** The purchase of this pick-up truck is a Plymouth County Commissioners Cooperative Bid to replace the 1992 old ambulance that was removed from service and declare surplus.

Finance Committee recommends.

**VOTED Aye unanimous to transfer the sum of \$21,500.00 from Article 5, Line 93, Highway Department Wages, of the May 2006 Annual Town Meeting, to purchase one (1) new ½ Ton pick-up truck for the Highway.**

**ARTICLE 7:** To see if the Town will vote to transfer a sum of money from the Mass Water Pollution Abatement Trust special revenue fund to the general fund maturing debt principal line or take any action in relation thereto.

Proposed by the Town Accountant and Treasurer/Collector

**Explanation:**~ This money is needed to pay down the debt that is due to the MWPAT

Finance Committee recommends.

**VOTED Aye unanimous to transfer a sum of \$10,000.00 from the Mass Water Pollution Abatement Trust special revenue fund to the general fund maturing debt principal line.**

**ARTICLE 8:** To see if the Town will vote to appropriate and raise by taxation or borrow from the Massachusetts Water Pollution Abatement Trust or otherwise the sum of \$800,000.00 for the purpose of financing the following water pollution abatement facility projects: repair, replacement and/or upgrade of septic systems, pursuant to agreements with Board of Health and residential property owners, including without limitations all costs thereof as defined in Section 1 of Chapter 29c of the General Laws or otherwise, or take any other action in relation thereto.

Proposed by the Board of Health & Treasurer/Collector

**Explanation:** We are seeking an additional \$800,000 from the trust for a third round of betterments. Requires a 2/3 vote, as it is borrowing.

Finance Committee recommends.

**VOTED Aye unanimous to appropriate the sum of \$800,000.00 for the purpose of financing the following water pollution abatement facility projects: repair, replacement and/or upgrade of septic systems, pursuant to agreements with Board of Health and residential property owners, including without limitations all costs thereof as defined in Section 1 of Chapter 29c of the General Laws; to determine whether this appropriation shall be raised by borrowing from the Massachusetts Water Pollution Abatement Trust.**

**ARTICLE 9:** To see if the Town will vote to transfer a sum of money from free cash and/or from the amounts appropriated in the May 2006 Annual Town Meeting, Article 5, Line 74 Disposal Area Operations for the engineering services to bring the transfer station into compliance with State solid waste management regulations as required by D.E.P. or take any other action in relation thereto.

Proposed by the Board of Health

**Explanation:** The Transfer Station site was never “assigned” for solid waste activities by the DEP. State regulations also require the site have a “Permit to Operate” which must be prepared by an engineer and submitted to DEP for approval.

Finance Committee recommends.

**VOTED Aye unanimous to transfer \$25,000.00 the May 2006 Annual Town Meeting, Article 5, Line 74 Disposal Area Operations for engineering services to bring the transfer station into compliance with State solid waste management regulations as required by D.E.P.**

**ARTICLE 10:** To see if the Town will vote to transfer a sum of money from the amount appropriated in Article 22 of the May 2005 Special Town Meeting for the Triennial Recertification of the Town’s values for the purpose of conducting recently mandated interim year adjustments for all classes of property or take any other action in relation thereto.

**Explanation:** The Department of Revenue has mandated that assessed values must be reviewed annually and adjusted to reflect 100% assessment every year.

Finance Committee recommends.

**VOTED Aye unanimous to transfer \$10,000.00 from Article 22 of the May 2005 Special Town Meeting, Triennial Recertification of the Town’s values, for the purpose of conducting recently mandated interim year adjustments for all classes of property**

**ARTICLE 11:** To see if the Town will vote to transfer a sum of money from free cash and/or stabilization funds to be added to the amounts appropriated in the May 2006 Annual Town Meeting, Article 5, Line 107, support staff Part-time or take any other action in relation thereto.

Proposed by the Fire Chief

**Explanation** These funds are required to keep the members of the Call Force available through the end of the fiscal year. The increase is due to an increase in call volume and in use of call members.

Finance Committee

**VOTED Aye unanimous to Pass Over.**

**ARTICLE 12:** To see if the Town will vote to transfer a sum of money from free cash and/or stabilization funds to be added to the amounts appropriated in the May 2006 Annual Town Meeting Article 5, Line 108 Fire Dept. Expense or take any other action in relation thereto.

Proposed by the Fire Chief

**Explanation** *These funds are required to pay the remaining bills for this fiscal year. Several large repairs to the tower truck caused the expense line to have this shortfall.*

Finance Committee

**VOTED Aye unanimous to transfer from Free Cash the sum of \$4,500.00 to be added to the Annual Town Meeting Article 5, line 108, Fire Department Expense.**

**ARTICLE 13:** To see if the Town will vote to transfer a sum of money from free cash and/or stabilization funds to be added to the amounts appropriated to the May 2006 Annual Town Meeting, Article 5, Line 106, support staff Full-time or take any other action in relation thereto.

Proposed by the Fire Chief

**Explanation:** These funds are required to meet payroll for the remainder of this fiscal year. An increase in calls and several serious windstorms last summer caused this shortfall.

Finance Committee recommends to Pass Over.

**VOTED Aye unanimous to Pass Over.**

**ARTICLE 14:** To see if the Town will vote to transfer a sum of money from the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 110, Other Tuition & Transportation and/or Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 14, Legal Expense or take any other action in relation thereto.

Proposed by the Board of Selectmen

**Explanation:** These funds are needed to cover the Legal expense for the remainder of the fiscal year.

Finance Committee recommends.

**VOTED Aye unanimous to transfer \$10,000.00 from Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 14, Legal Expense.**

**ARTICLE 15:** To see if the Town will vote to transfer a sum of money from the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 110, Other Tuition & Transportation and/or Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 18, Utilities or take any other action in relation thereto.

Proposed by the Board of Selectmen

**Explanation:** The increase in fuel and energy costs have depleted the Utility Line.

Finance Committee recommends to Pass Over.

**VOTED Aye unanimous to Pass Over.**

**ARTICLE 16:** To see if the Town will vote to transfer a sum of money from the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 110, Other Tuition & Transportation and/or Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting Article 5, Line 20 Town Building Expenses or take any other action in relation thereto.

Proposed by the Board of Selectmen

**Explanation:** This transfer is requested to replenish the Town Building Expense line, which includes custodial supplies and maintenance repairs for the Town Hall, Senior Center and Library.

Finance Committee recommends.

**VOTED Aye unanimous to transfer a sum of \$3,000.00 from Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting Article 5, Line 20 Town Building Expenses.**

**ARTICLE 17:** To see if the Town will vote to transfer a sum of money from the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 110, Other Tuition & Transportation and/or Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 31 Selectmen's Expense or take any other action in relation thereto.

Proposed by the Board of Selectmen

**Explanation:** This transfer is requested to cover Selectmen's expenses for tuition reimbursement for the clerical staff

Finance Committee recommends.

**VOTED Aye unanimous to transfer a sum of \$1,000.00 from Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 31 Selectmen's Expense.**

**ARTICLE 18:** To see if the Town will vote to transfer a sum of money from the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 110, Other Tuition & Transportation and/or Free Cash to be added to the amount appropriated to the 2006 Annual Town Meeting, Article 5, Line 12 Computers Expense or take any other action in relation thereto.

Proposed by the Board of Selectmen

**Explanation:** This transfer is requested to cover the costs for computer services, repairs and replacement of the server.

Finance Committee recommends.

**VOTED Aye unanimous to transfer a sum of \$20,000.00 from Free Cash to be added to the amount appropriated to the 2006 Annual Town Meeting, Article 5, Line 12 Computers Expense.**

**ARTICLE 19:** To see if the Town will vote to transfer a sum of money from the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 110, Other Tuition & Transportation and/or Free Cash to be added to the amount appropriated to the 2006 Annual Town Meeting, Article 5, Line 16 Engineering Expense or take any other action in relation thereto.

Proposed by the Board of Selectmen

**Explanation:** This transfer is requested to cover the engineering costs for various town projects.

Finance Committee recommends.

**VOTED Aye unanimous to transfer a sum of \$10,000.00 from Free Cash to be added to the amount appropriated to the 2006 Annual Town Meeting, Article 5, Line 16 Engineering Expense.**

**ARTICLE 20:** To see if the Town will vote to transfer a sum of money from the amount appropriated to the May 2006 Annual Town Meeting, Article 5, Line 110, Other Tuition & Transportation of and/or Free Cash to be added to the amount appropriated to the May 2006 Annual Town Meeting Article 5, Line 6 Town Benefits or take any other action in relation thereto.

Proposed by the Treasurer/Collector

**Explanation:** This transfer is requested to cover the increase in benefits costs for new hires.

Finance Committee recommends to Pass Over.

**VOTED Aye unanimous to Pass Over.**

**ARTICLE 21:** To see if the Town will vote to transfer \$1,500.00 from amounts appropriated in the May 2006 Annual Town Meeting Article 5, line 46, Election Wages and \$500.00 from Line 48, Registrars Wages, for the purpose of restoring and microfilming Town Records or take any other action in relation thereto.

Proposed by the Town Clerk

**Explanation:** This money would be used to restore Book I, Births, Marriages and Deaths from the early 1800's which, until recently, was thought to have been lost until it was found in the deep recesses of the Town Hall cellar in very poor condition. Other books from the 1800's are Marriage Intentions, the Pauper Registry and the Overseers of the Poor.

Finance Committee recommends.

**VOTED Aye unanimous to transfer \$1,500.00 from amounts appropriated in the May 2006 Annual Town Meeting Article 5, line 46, Election Wages and \$500.00 from Line 48, Registrars Wages, for the purpose of restoring and microfilming Town Records.**

**ARTICLE 22:** To see if the Town will vote to transfer a sum of money from free cash and/or Stabilization for the installation and associated work needed for the Cranberry Cove beach septic system, or take any other action hereinto.

Proposed by the Hanson Recreation Commission

**Explanation:** The septic system for the Cove is in failure and needs to be replaced. Most of the work will be performed by Town departments and through volunteer efforts. However, some of the materials will have to be purchased.

Finance Committee recommends.

**VOTED Aye unanimous to transfer \$15,000.00 from Free Cash for the installation and associated work needed for the Cranberry Cove beach septic system.**

**ARTICLE 23:** To see if the Town will vote to transfer a sum of money from Free Cash and/or the amounts appropriated in the May 2006 Annual Town Meeting, Article 5, Line 8 Unemployment to be added to the amounts appropriate in the May 2006 Annual Town Meeting Article 5, line 104, Communication Center Dispatchers, Expenses or take any other action in relation thereto.

Proposed by the Police Chief

**Explanation:** These funds are necessary to meet the communications center operating expenses for the balance of this fiscal year.

Finance Committee recommends.

**VOTED Aye unanimous to transfer the May 2006 Annual Town Meeting, Article 5, Line 8 Unemployment the sum of \$4,500.00 to be added to the amounts appropriate in the May 2006 Annual Town Meeting Article 5, line 104, Communication Center Dispatchers, Expenses.**

**ARTICLE 24:** To see if the Town will vote to amend Article 1 –2 Procedures of Town Meeting of the Hanson General By-laws by adopting the follows new section:

***Section 12***

The Moderator may take all votes requiring a two-thirds majority in the same manner in which he or she conducts the taking of a vote when a majority vote is required. If the Moderator's declaration is immediately questioned by seven or more voters, the Moderate shall verify the vote by a count.

or take any other action in relation thereto.

Proposed by the Moderator

**Explanation:** This amendment will afford the Moderator the ability to declare a two-thirds majority on a voice vote.

**VOTED Aye unanimous to Pass Over.**

**ARTICLE 25:** To see if the Town will vote to amend Article 2 –11 Capital Improvement Committee of the Hanson General By-laws, Section 4 by inserting in Line 1 the words "or special" following the word "annual" or take any other action in relation thereto.

Proposed by the Capital Improvement Committee

**Explanation:** This amendment will allow the Capital Improvement Committee to submit Capital Improvement articles into a Special Town Meeting Warrant provided that such item has been included on the Capital Improvement plan for that fiscal year.

**VOTED Aye unanimous to amend Article 2 –11 Capital Improvement Committee of the Hanson General By-laws, Section 4 by inserting in the first sentence the words "or special" following the word "annual".**

**Explanation:** This article is voted yearly to set the ranges for Wage & Personnel employees.

Finance Committee refers to Town Meeting.

**VOTED Aye unanimous to amend the Wage and Personnel Bylaw, Article 2-12, Classification and Compensation as printed in the Warrant.**

**ARTICLE 27:** To see if the Town will vote to accept the provisions of Chapter 40, Section 42J of Massachusetts General Laws or take any other action in relation thereto.

Proposed by the Water Commissioners

**Explanation:** This is a local option statute and must be accepted by Town Meeting. Eligibility to defer water charges will be limited to those senior citizens who qualify for and actually receive a tax deferral. In the first year that a deferral of water charges is sought, the taxpayer would apply to the Water Commissioners. The Commissioners would notify the Board of Assessors of the water charges to be deferred for the year. The Assessors would then defer the water charges, along with the deferred taxes. Payment of the deferred charges are secured by the same lien statement recorded under Clause 41A(tax deferral). Interest would accrue at the same rate as on deferred taxes (5%).

Finance Committee recommends.

**VOTED Aye unanimous to accept the provisions of Chapter 40, Section 42J of the Massachusetts General Laws.**

**ARTICLE 28:** To see if the Town will vote to accept the provisions of Chapter 80, Section 13B of Massachusetts General Laws or take any other action in relation thereto.

Proposed by the Board of Health

**Explanation:** This is also a local option statute and must be accepted by Town Meeting. This option will permit qualified low-income senior citizens to defer payment of betterments and other special assessments.

Interest would be charged at the regular delinquency rate from the end of the 180-day period, unless the returning guardsmen/reservists are still on active duty status and qualifies for the lower 6% rate under the Service Members Civil Relief Act.
