## **NEW BUSINESS**

## I. New Business:

- (1) Approve BOH Minutes for May 11, 2021, Ms. Dias made a motion to approve the BOH minutes for May 11, 2021, 2<sup>nd</sup> by Mr. O'Connell. 2-0-1
- (2) The next BOH meetings will be held on Tuesday, July 13th.
- (3) Board Re-Organization Mr. Perkins nominated Mr. O'Connell as chairman, 2<sup>nd</sup> by Mr. O'Connell 3-0, Mr. O'Connell made a motion to nominate Mr. Perkins as Vice Chair, 2<sup>nd</sup> by Mr. Perkins 2-0-1.
- (4) Well Permit 92 Pleasant Street Ms. Dias made a motion to approve the well permit, with the requirement that an as-built be submitted with well location, 2nds by Mr. Perkins. 3-0
- (5) Well Regulations Mr. Perkins would like all wells installed to submit an as-built after installation prior to a final sign-off. Several drillers have questioned the requirement of testing for irrigation wells. The Board does not see the necessity. Updated Regulations will be submitted at the next meeting.
- (6) Septic Plans
  - **85 High Street** 3 Bedroom Mr. Perkins made a motion to allow for the following variances, 2<sup>nd</sup> by Ms. Dias. 3-0.
  - a. Variance to allow a minimum vertical separation from the soil underlying the SAS above the high ground water elevation shall be 4' with a recorded perc. rate of greater than 2 minutes per inch. A variance would allow a vertical separation reduction from the required 4' to 3'.
  - b. To allow the use of a grain size distribution analysis to establish design load rate.
  - **36 Ocean Avenue** 2 Bedroom Deed Restriction Tight Tank Mr. Perkins made a motion to allow for the following variances, 2<sup>nd</sup> by Mr. O'Connell. 2-0. Ms. Dias abstained.
  - a. Allow the installation of a tight tank instead of a septic system.
  - b. Allow a tight tank 0.5' from an unconstructed paper street line (Depot Street) instead of the 10' required.
  - c. Allow the invert elevation into the tight tank to be less than 12" from the soil mottling.
  - d. Allow the proposed tight tank to be 3' from a property line instead of the 10' required.
  - **53 West Washington Street** 8 Bedroom Mr. Perkins made a motion to allow for the following variances, 2<sup>nd</sup> by Ms. Dias. 3-0
  - a. To allow the use of a grain size distribution analysis to establish design load rate.
  - **202 Forest Trail** 4 Bedroom Ms. Dias made a motion to allow for the following variances, updated plans should be submitted to the office, 2<sup>nd</sup> by Mr. Perkins 3-0
  - a. Variance to allow a minimum vertical separation from the soil underlying the SAS above the high ground water elevation shall be 4' with a recorded perc. rate of greater than 2 minutes per inch. A variance would allow a vertical separation reduction from the required 4' to 3'.
  - b. To allow the use of a grain size distribution analysis to establish design load rate.
  - **114 Progress Way** 3 Bedroom Ms. Dias made a motion to allow for the following variances, 2<sup>nd</sup> by Mr. Perkins. 3-0
  - a. To allow for the use of a frimpter calculation to establish high ground water.
