Ms. Cocio will run the numbers for Waste zero invoiced amounts and deposits and forward the information to the Board. The traffic study conducted in 2019 should still be valid. Can we use high school students to man a take it/leave it area? Ms. Dias will take on Education issues pertaining to the TS.
