

**Minutes for
Town of Hanson
Board of Health Meeting
Tuesday, September 15, 2020**

Having a quorum, Mr. O'Connell called the meeting to order at 4:00pm

NEW BUSINESS

I. New Business:

1. Bill Gottwald – Installers Permit – Mr. Gottwald will submit 2 current installer permits to meet the requirement to sit for the test.
2. Bag Ban – Ms. Dias would like the Board to re-consider the extension of the re-useable bag ban. She feels re-useable bags are being used in several other towns as long as the customer packs the bags themselves. Ms. Dias made a motion for Hanson to return to pre-covid levels and allow the use of re-usable bags, 2nd by Mr. O'Connell. 3-0
3. Emergency Preparedness – Ms. Dias would like to replace some of the Emergency Preparedness expired supplies. Syringes, chemical testing kits for spills etc. She will check stock and perhaps submit an article for the October Town Meeting to purchase replacements.
4. Septic Plans
 - a. **339 Main Street – 3 Bedroom** – Mr. Perkins made a motion to allow for the following variances, 2nd by Ms. Dias. 3-0
 - i. To allow for a reduction in system location setbacks from the slab foundation SAS to Slab from the required 10' to requested 7'
Septic tank to foundation from the required 10' to requested 7'
 - ii. To allow for a reduction in system location setbacks
SAS to property line from required 10' to requested 5' side and 6' rear.
 - b. **195 Woodbine Ave. – 4 Bedroom – Deed Restriction** - Mr. Perkins made a motion to allow for the following variances, 2nd by Ms. Dias. 3-0
 - i. To allow a reduction in the separation between the bottom of the SAS and the maximum seasonal high water table from 5' to 4'
 - c. **23 Winslow Drive – 3 Bedroom – Sieve – Deed Restriction** - Mr. Perkins made a motion to allow for the following variances, 2nd by Ms. Dias. 3-0 Pending receipt of revised plans with a Deed Restriction notation.
 - i. To allow a reduction in the separation between the bottom of the SAS and the maximum seasonal high water table from 4' to 3'
 - ii. To allow a grain size distribution analysis to establish design load rate
