IV TOWN ADMINISTRATOR'S REPORT

Mr. McCue clarified the discussion from the last meeting regarding the Recreation and the committee's duties which were to broaden to include town wide activities. Mr. McCue noted no changes will be happen in the near future. There will be a meeting of the parties prior to changing the charge of the Recreation Commission. Mr. McCue explained that the original charge of the Committee was for town wide activities. Mrs. FitzGerald-Kemmett concurred with Mr. McCue. There will be a discussion before any changes in duties or charge for the committee will occur.

Mr. McCue explained there are no school flashing lights at the Indian Head School. The School Department wishes to install the solar signs along Indian Head Street. A survey will be conducted to determine the location of the signs. If they need to be place on an abutters' property, a hearing will be required. There is a potential for two additional signs at the cross walk to Botieri Field parking lot. The School Committee will seek reimbursement at the Special Town Meeting in the amount of \$12,000 and possibly \$24,000 if the cross walk signs are approved by the Highway Department.

MOTION by FitzGerald-Kemmett, second by Dyer to authorize \$12,000 for school signage at Indian Head School. *Voted* 5 - 0

Mr. McCue reviewed a letter which has been issued by the Town of Hanover regarding work at the Fireworks Site on King Street in Hanover. A hover craft is currently being used to map the topography. They will commence the detonation of the munitions on January 7th. The more work they conduct, the more items they find.

JJ's Pub update. Mr. McCue reported that Town Counsel was not required to return to court because the original injunction was all encompassing addressing the both the fencing and clean up of the property. Mr. McCue indicated testing has determined there is hazardous materials in the debris pile. It is not a public safety concern. The estimated cost for removal is \$40,000.00. Mr. McCue is unsure whether the Town has the funds to cover the costs. Mr. McCue had approached Finance Committee for funding for the fence of \$5,000. The additional \$40,000 will significantly impact the Reserve Fund. If the Town is required to fund the removal of the debris, a lien will be placed on the property.

Chairman Mitchell would like to have a fence installed. He wants more discussion relative to the clean up. Mr. McCue noted the hazardous materials increased the clean up cost significantly. Mr. McCue cannot determine whether there is a potential buyer.
