Mr. Clemons suggested that the Commission approve the work at Smitty's Bog to relieve flooding problems at Katydid Lane for the reasons outlined in a letter dated 10/15/2015. He said that the idea is to simply take action on a town funded project that for all intents and purposes is part of the Wetlands Restoration Plan of Operation (WRPO) to enhance the natural flow of water at the bogs. Mr. Clemons added that it's minor in nature, was discussed at a public hearing and after numerous site walks, the Natural Resources Conservation Services (NRCS) designed a diagram into the approved Plan to connect wet areas which the dike had disconnected. Mr. Kemmett wanted to make sure that the Stormwater Management Plan (MS4) will be updated after the work is done.
