**8:00 PM Request for Determination of Applicability** to construct a 14′ X 58′ in-law apartment addition to an existing structure. Proposed work will occur within 100′ buffer zone to bordering vegetated wetlands at 126 Pierce Avenue, Map 41, Lot 8, for Laurence Tardiani.

Mr. Mansfield read the Public Hearing Notice and the green cards were verified.

Mr. Tardiani is proposing to construct an in-law apartment addition to existing structure which would include a full basement. The back corner and bulkhead will intersect the buffer zone. The work would include excavation of soil outside of buffer zone, silt socks along 50' buffer zone. The excavation site is all grass, there will be no tree removal in the buffer zone.

Agent Schellenger stated that the wetland is bordering a potential vernal pool. The presentation was clear and he recommends a Negative 3 Determination.

He has chosen to pay for the American Chestnut Foundation Seed Level Membership which includes 3 seedlings.

## Conservation Properties Status/Property Management Update

**Smitty's Bog;** Mr. Smith purchased deer repellent for newly planted Cedar trees at Smitty's Bog. Discussion of unauthorized duck blind structure at Smitty's Bog.

USDA deed to be researched. It is due to renew and it is renewed every five years. This is also an opportunity to view compatible use agreements.

**Smith Nawalzelski**; Weed whacking, pasture rose removal, path clearing to kiosk needed. **Bonney Hill Trail**; Gate has been painted green.

Mr. Mansfield met with Marianne DiMascio from Green Hanson. She would like to know what can be done for trail maintenance. Discussion on a possible Adopt-a-Trail. Ms. DiMascio would like to promote this idea on her cable access show.

Commission to provide descriptions for this; litter control, invasive species control, manure removal. We would also not want trees removed or bridges built without Conservation Commission communication.

Agent Schellenger stated that Town Counsel is waiting for survey of the 2 parcels on Brook Street, both Conservation property, in the process of getting deeded by Select Board. Bid requests are in and there is a request for Water Department to pay for the survey.

Chair Clemons spoke to Jerry Davis, Water Department, and he is aware. The 3 survey quotes submitted range in price and all are less than \$10,000. It is in the Town's best interest to get extra land credits. By protecting more Open Space, the Water Department can get these credits.

Mr. Heal mentioned there were two items on June 27, 2023 Select Board Agenda: Appointment of Laura Salonga, Conservation Commission Member, 3-year term, and Pond Management Discussion.

Concerns regarding appointment since board already has 5 members. Mr. Heal also notified Commission that the Select Board were not aware they have jurisdiction of Pond Management. Chair Clemons stated that clarity is needed for this responsibility.
