Old business:

Follow up survey and planning grant application. Letter was sent to Massachusetts Historical Commission and Tom received and e-mail from Mike Stein the the pre-app was approved. We need to fill out the application at our January meeting.

Mr. McCue agreed to include HHC in the land protocol. Mr. McCue stated the land surrounding the Bonney House has to be checked with the assessors. Tom will followup. Mr. McCue will support a survey grant and there is some movement on getting people for the Bi-Centennial Committee.

Tom stated there is a grant of 50% reimbursable matching funds and the deadline is late March – may be used for painting the School House #4.

Tom states the the HHC should have a long range plan, what is important and when and to check it with open space & CPC. We influence how town budgets for Bicentennial, Heritage Markers, Water wheel for Thomas Mill, Historic boulder markers. We need the original survey cost to finish the survey. Contact Laura for CPC.

The Goals stated in their project. 1st- Preserve historic buildings and objects at Camp Kiwanee, restore and conservation of historic documents and artifacts and cemetery restoration projects.

2nd-Provide vault or other improvements as part of a library expansion to store/preserve historic records and artifacts, establish historic museum at Bonney House and complete forms to nominate specific buildings and sites to State or National Registry. We discussed Cushing House, Gad Hitchock or Bonney House.

CPC to review historic portions.

Tom got an inquiry from Mr. McCue about the caretaker's house and gate house garage. The garage is in very disrepair and wanted to know if it was historic or could it be demolished. Mr. Bob Curren states the garage was built on cinder block and no frost protection and recommends removal as does Phil Clemons and Allan Clemons. Tom moved we write a letter to Mr. McCue stating we feel the gatehouse garage at Camp Kiwanee can be demolished. Seconded by Allan. Passed 4-0. Patty will write letter.

Other business:

Allan stated he has everything ready at the Bonney House so when Voc-Tech students come they can just shingle. Tom suggested we publicize that we are going for a grant, and then if we get it or not, make that public. Agreed by everyone.
