## **DISCUSSIONS**

**Section 6.5.4 of the Sub-division Rules and Regulations** – The text of the regulations do not match the detail sheet at the end of the regs as it relates to roadway widths.

## STREET CLASSIFICATION

6.5.4 Depending on the amount of traffic they will be expected to accommodate, the streets in town, except state highways, shall be classified as arterial, collector, local and minor. The classification of a proposed street shall be determined by the Planning Board. Stopping sight distances for all streets shall conform to standards for horizontal and vertical alignment and intersections given in the American Association of State Highway and Transportation Officials "A Policy on Geometric Design of Rural Highways" latest revised publication.

### **COLLECTOR STREETS**

A. Collector streets shall include streets expected to accommodate traffic generated by one or more subdivisions or neighborhoods, or streets connecting parts of the town or carrying industrial or commercial traffic but not serving as major thoroughfares. Collector streets shall have *a right-of-way width of 50 feet*, minimum

pavement width of 32 feet, and a minimum sight distance of 200 feet.

#### LOCAL STREETS

B. Local streets shall include dead-end streets of over 200 feet in length and all streets not otherwise classified and shall have a *right-of-way width of 40 feet*, minimum pavement width of 26 feet, and a minimum sight distance of 150 feet.

## **MINOR STREETS**

C. Minor streets shall include residential streets expected to carry only the traffic generated by the residences on such street and in the immediate proximity thereof and shall have *a right-of-way width of 40 feet*, minimum pavement width of 20 feet, and a minimum sight distance of 125 feet

The Board is in agreement that the roadway widths are correct in the written text and the detail needs to be changed. They will review the rest of the rules and regs to determine if there are other changes that need to be addressed at a future public hearing.

# Stormwater Management By-Law

The Planning Board is responsible for stormwater management under Article 3-21 and the Board of Health is responsible for Illicit Discharges. Ms. Muncy will meet with the BOH to inquire as to whether or not they are still interested in Illicit Discharges or would they prefer the Planning Department to take the lead role. Should revisions be made to the By-Law, it would have to be at Town Meeting.
