On May 27, the annual Memorial Day celebrations will begin at 9:45 AM at Indian Head Elementary School with a brief ceremony and lowering of the flag to half-staff. The parade will proceed to Fern Hill Cemetery, stopping along the way to Town Hall to lay a wreath at the Civil War memorial. At the Cemetery, the ceremony will include opening and closing prayers, readings of the Governor's Proclamation and of Veterans' Names who passed this year as well as a guest speaker.

Following the ceremony, at 12:00pm, the Hanson American Legion Post 226, located at 92 Robinson Street, will host a luncheon for all Memorial Day attendees.
