#### **Drainage Discussion**

He discussed his love for the Town of Hanson, career, and Select Board time and experience with the Commission. He has an issue and concern with Cushing Trails.

Chair Clemons notified Mr. Howard the we do not have jurisdiction of Cushing Trails. There are a number of projects presented to the Commission and we are very strict regarding the Stormwater Management Plans. If we see any indication of issues, we deny the project. There have been Applicants that have returned with re-designs which have been approved. If the project is not near wetlands, we do not have jurisdiction.
