Proposed by the Select Board

Explanations:

Line 1 & 3 – Plymouth County wants to see that Town meeting approved as part of the grant application process;

Line 2 – This will be reappropriating the Library/Senior Center money to purchase a generator voted at the October 3, 2022 Special Town Meeting, Article 8 as it was not approved by ARPA.

Recommendations: Select Board: Placed and Recommended Voted 5 – 0

ARTICLE 3: To see if the Town will vote to transfer from available funds \$15,000 for improvements of Grading and the filling potholes on Private Roads; or take any action in relation thereto.

Proposed by the Highway Director

Explanation: This will provide funding and authorize the grading of all private gravel roads in the Town of Hanson up to two times per year. These funds would be used to provide for purchasing any material and to properly pitch and grade and the roads to the proper elevations and compact the material which should help to stabilize these roads. These funds are also required for this purpose as well as to fill potholes with suitable materials as necessary for public safety, plowing and emergency access on private roads.

This money should be available immediately after funding approval for Spring Grading.

ARTICLE 4: To see if the Town will vote to appropriate \$50,000 from the Community Housing Reserve to the Hanson Housing Authority for the purposes of updating/developing a Housing Production Plan or take any other action in relation thereto.

Proposed by the Community Preservation Committee

Explanation: A Housing Production Plan (HPP) is valid for five years and Hanson's will expire on May 21, 2024. The plan assists Hanson Housing Authority in addressing the town's need for affordable housing. This plan is developed locally and, can influence and inform how, when, and where affordable housing is built in town. An approved Housing Production Plan assists the Town of Hanson in receiving grant funding.

ARTICLE 5: To see if the Town will vote to transfer \$6,500 from amount appropriated at the October 2, 2017 Special Town Meeting Article 11 to fund procurement expenses related to Pratt Place Culvert construction.

Explanation: The Pratt Place Culvert is in need of repair or replacement; these funds are needed for procurement expenses.
